January 2024 Future Collector Car Show Photo Contest

OFFICIAL RULES

PLEASE READ THESE RULES CAREFULLY. BY ENTERING OR PARTICIPATING IN THIS CONTEST YOU AGREE TO BE BOUND BY THESE TERMS/OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.

- 1. Eligibility: The January 2024 Future Collector Car Show ("FCCS") Photography Contest (the "Contest") is open to legal residents of the 50 United States and the District of Columbia, who are at least 18 years of age. Participation in the Contest constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Contest. Winning the prize is contingent upon fulfilling all requirements set forth herein. The Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited by law. The following persons are not eligible to enter the Contest: (a) employees of Barrett-Jackson Auction Co. LLC ("Company"), its affiliates, subsidiaries, parent companies, officers or employees; (b) officers, employees or agents of any organizations directly involved with this Contest, and (c) immediate family members and persons living in the same household as the persons identified in (a) and (b) above.

- 3. **Contest Period**: The Contest begins on January 21, 2024, at 8:00am MST and ends on February 9, 2024 at 11:59 pm MST. All entries must be entered or received by February 9, 2024.
- 4. **How to Enter**: The photos must be taken onsite during the FCCS on January 21, 2024 on the "Polo Fields" at Westworld in Scottsdale, Arizona and each entry must be submitted via the FCCS website, available at: https://fccs.barrett-jackson.com/ Each entrant may submit up to five photos. All entries, once submitted, become the property of Sponsor and will not be acknowledged or returned. Use of any automated system or of multiple accounts to enter the Contest is prohibited and may result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which will be disqualified. Display or publication of any photo on Sponsor's websites, social media, or otherwise does not indicate the entrant will be selected as a winner. Sponsor will not be required to pay any consideration or seek any additional approval in connection with use of an entry.

5. Requirements for Entry:

Entries must have the name, e-mail address, and phone number of the entrant included in the entry. Entries received without this information will not be considered.

- 1. The photo submitted must be entrant's original, previously unpublished creation and owned and taken solely by the entrant.
- 2. Photo must be taken during FCCS on January 21, 2024, on the Polo Field at WestWorld of Scottsdale, in Scottsdale, Arizona.
- 3. Entrant must have permission from any individuals that appear in the photo to use their name and likenesses in the photo and to grant the rights set forth herein. If requested, entrant shall be able to provide such permissions in a form acceptable to Sponsor.
- 4. Only previously unpublished photos may be entered.
- 5. The photos submitted should capture the vibe of the FCCS with your best shot!
- 6. The photos submitted shall not be derogatory, offensive, threatening, defamatory, disparaging, libelous or contain any content that is inappropriate, indecent, sexual, profane, tortious, slanderous, discriminatory in any way.
- 7. The photo submitted shall not contain material that violates, misappropriates or infringes upon any law or regulation or the rights of any third party including, but not limited to, any copyright, trademark or any rights of publicity or privacy, or any other intellectual property or proprietary rights.
- 8. By entering the Contest, entrants warrant and represent that they are the exclusive owners of the photo submitted and have obtained all permissions necessary for Sponsor to display, post, license, publish or use the photo submitted as set forth in these Official Rules and in promotional materials relating thereto.
- 6. License to Use Entries and/or Photo Submissions: By entering or participating in the Contest, all entrants hereby irrevocably grant to Sponsor, its affiliates, licensees, agents and service providers a royalty-free, fully paid-up, perpetual, transferable, sublicensable, worldwide, non-exclusive license to use, perform, display, reproduce, distribute, modify, make derivative works of, make, have made, sell, offer to sell, import, and otherwise exploit the photos or images submitted and/or each element of an entrant's entry (including, but not limited to, the photos submitted) in connection with the Contest, the promotion of the Contest, Sponsor's business activities, FCCS, and in any other manner at the discretion of Sponsor or its licenses in any media now or hereafter known including, but not limited to, on social media pages and other digital media, newsletters, digital content, third party sites, print materials, television and other broadcast media, for marketing and/or advertising in perpetuity.

To the fullest extent permitted by applicable law, entrant hereby irrevocably waives all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages, and expenses, including but not limited to claims for copyright or trademark infringement, infringement of moral rights, libel, defamation, invasion of any rights of privacy (including intrusion, false light, public disclosure of private facts, and misappropriation of name or likeness), violation of rights of publicity, or any similar claim or cause of action in tort, contract, or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, "Claims"), arising directly or indirectly from the exercise of rights by Sponsor, its affiliates, licensees, agents and assignees and other working for it or on its behalf under these Rules or the

production, exhibition, exploitation, advertising, promotion, or other use of entrant's entry, and whether resulting in whole or in part from the negligence of Sponsor, its affiliates, licensees, agents and assignees and other working for it or on its behalf, or any other person, and entrant hereby covenants not to make or bring any such Claim against Sponsor, its affiliates, licensees, agents and assignees and other working for it or on its behalf, and forever releases and discharges the Sponsor, its affiliates, licensees, agents and assignees and other working for it or on its behalf from liability under such Claims.

Display or publication of any photo on Sponsor's website, social media, or otherwise does not indicate the entrant will be selected as a winner. Sponsor will not be required to pay any consideration or seek any additional approval in connection with use of an entry.

- 7. **Winner Determination**: Once all entries have been submitted, they will be judged by automotive photographer Larry Chen and the 2023 FCCS photo winner, Brandon Locket at the conclusion of the Contest period based generally on the following judging criteria:
 - Creativity
 - Fit to the Contest theme
 - Quality of Picture

In the event of a tie for a potential winner, the head judge will select the potential winner based on creativity of the photo.

- 8. Winner Notification: The potential prize winner will be notified by email at the addresses provided on the entry form. If the potential prize winner cannot be contacted within five days after the date of the first attempt to contact him/her or the prize is returned as undeliverable, the potential prize winner forfeits the prize and Sponsor reserves the right to award the prize to another entrant. The potential prize winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The prize will be fulfilled approximately 4-8 weeks after the conclusion of the Contest.
- 9. **Prizes**: There will be one prize as follows: \$1,000 and an FCCS swag bag. Prize winner is responsible for all taxes and fees, if any, associated with prize receipt.
- 10. **General Conditions**: Sponsor reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Contest, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Official Rules of this or any other Contest or in an inappropriate, unsportsmanlike or disruptive
